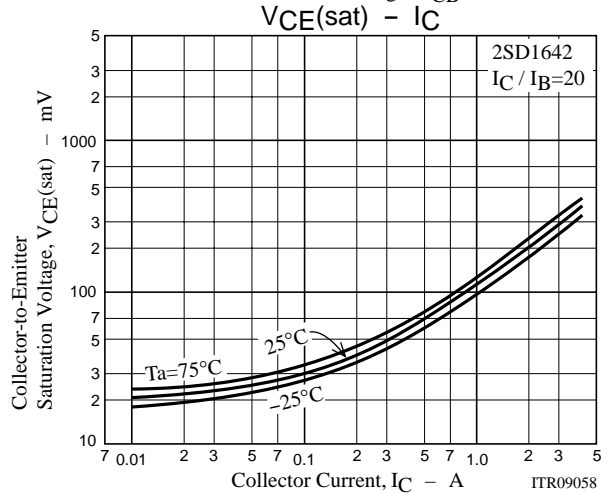
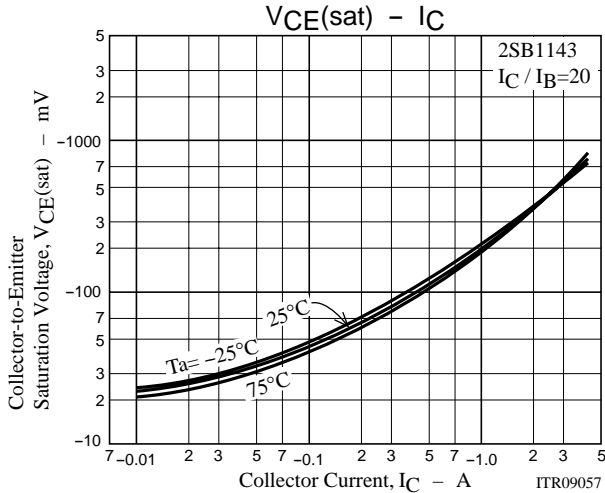
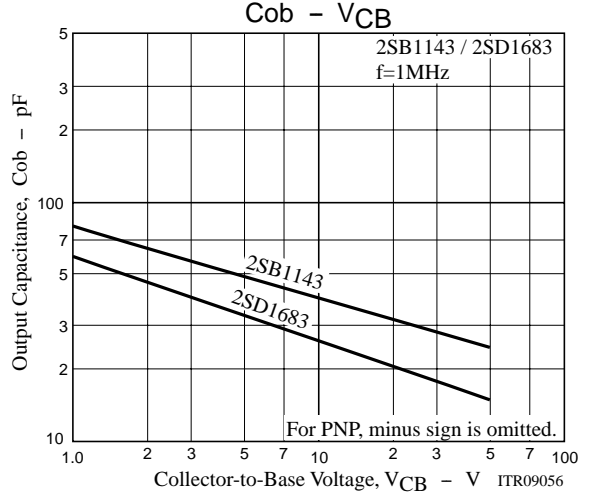
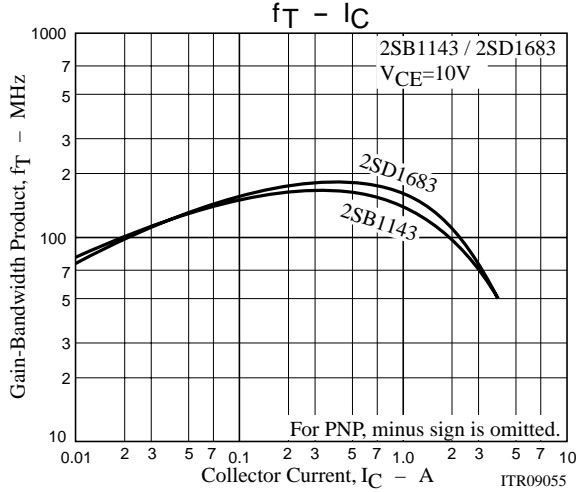
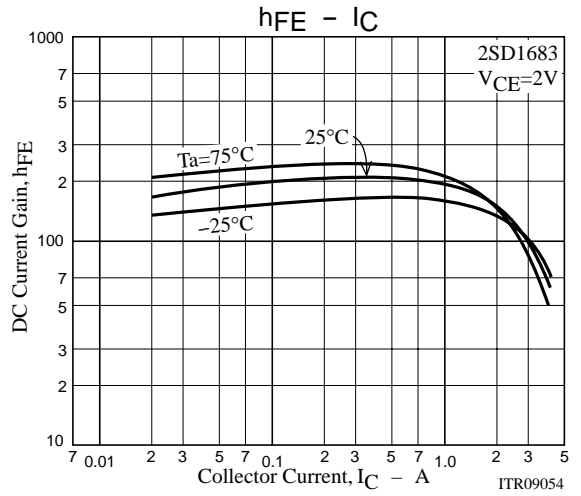
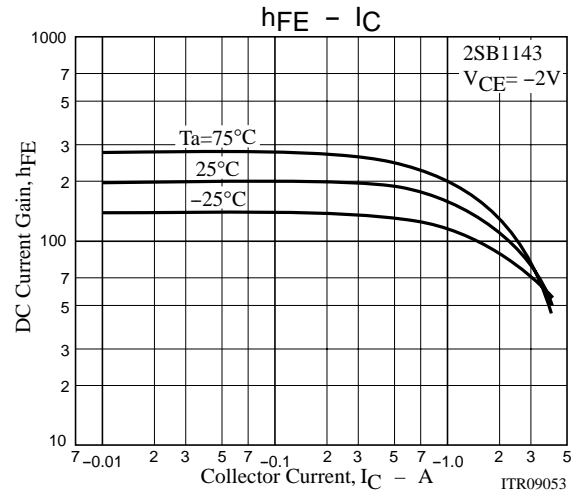
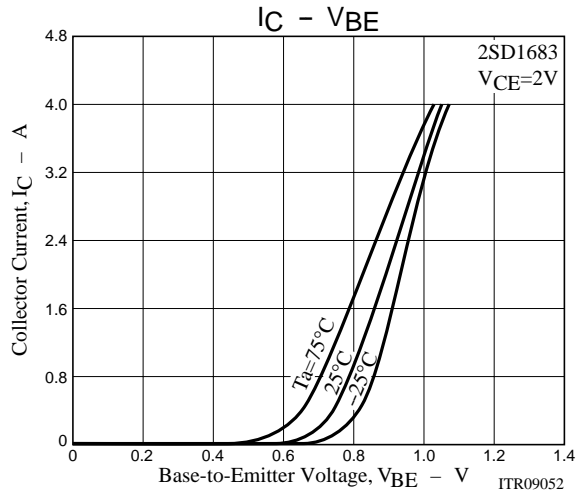
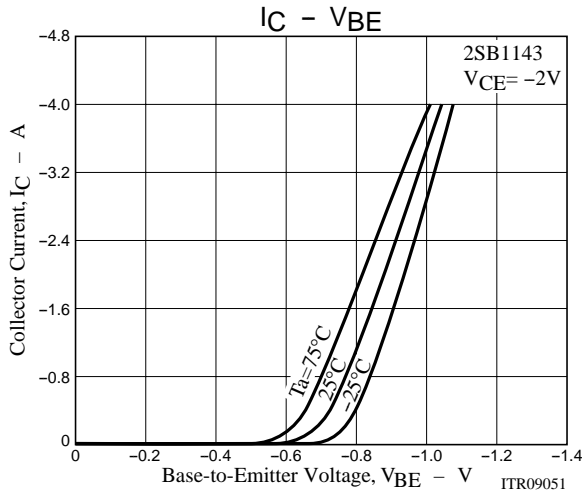
Switching Time Test Circuit



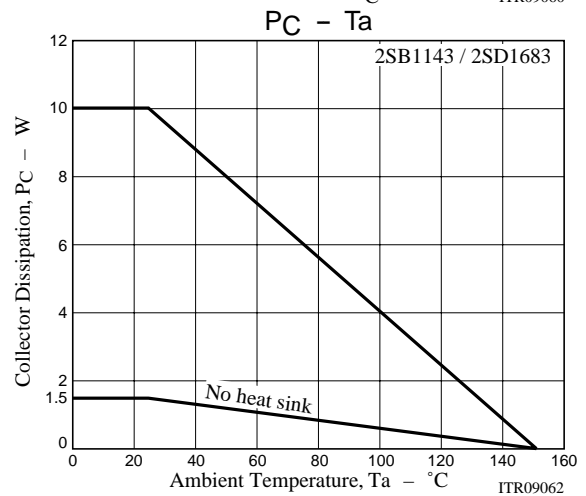
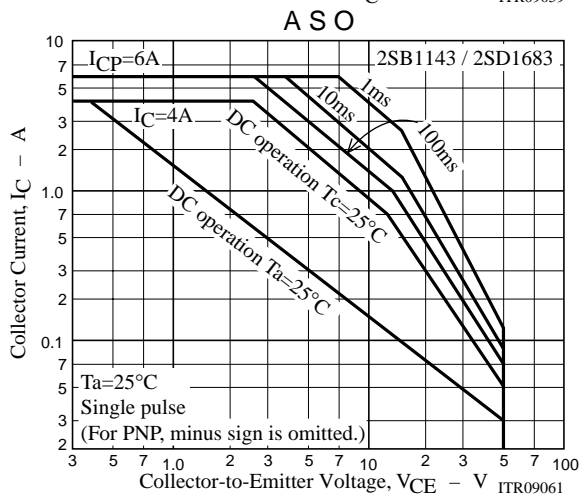
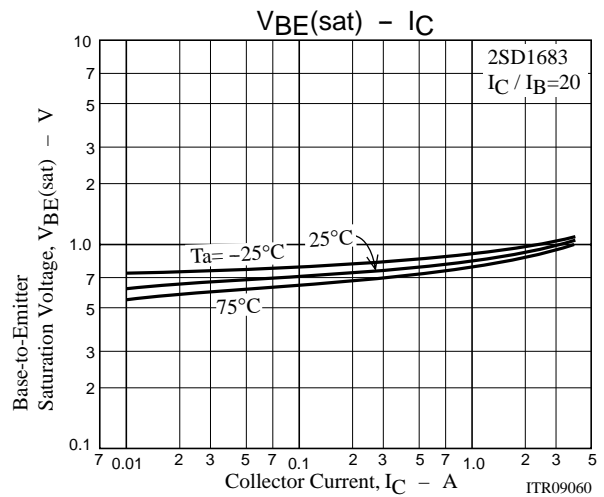
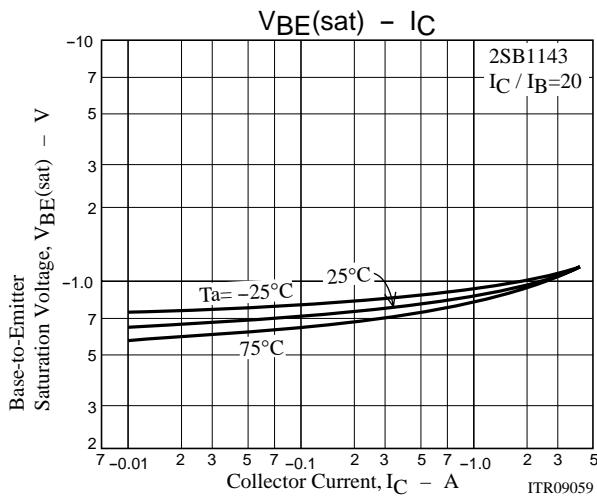
